A regular meeting of the City Council of the City of Harbor Beach was held on Monday, April 15, 2024 at City Hall. The meeting was called to order at 7:00 p.m. by Mayor Guitar.

Resolution # 2024-35 "Approving Wages for Newly Hired Part-Time Seasonal Employees and Increases for Returning Part-Time Seasonal Employees" was presented to Council. It was moved by Woodke, seconded by Woodward to adopt Resolution # 2024-35 as presented. The Resolution reads as follows: WHEREAS, Department Heads are requesting to hire part-time seasonal employees per the attached sheet; and

WHEREAS, Department Heads are recommending hiring returning part-time seasonal employees with a wage increase per the attached sheet;

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Harbor Beach approves hiring part-time seasonal employees per the attached sheet and approves hiring returning part-time seasonal employees with a wage increase per the attached sheet. Motion carried. 5 yeas.

Resolution # 2024-36 "Awarding Bid to Fahrner Asphalt Sealers, LLC to Chip & Fog Seal Lytle Avenue and Nelson Street" was presented to Council. It was moved by Woodward, seconded by Wood to adopt Resolution # 2024-36. The Resolution reads as follows: WHEREAS, Lytle and Nelson streets in the City of Harbor Beach both need Chip and Fog Seal; and

WHEREAS, DPW Superintendent Jurgess solicited bids from different companies; and

WHEREAS, Superintendent Jurgess and the DPW Committee are recommending that the City award the bid to Fahrner Asphalt Sealers, LLC for the Chip and Fog seal on these two streets; See attached bid

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Harbor Beach awards the bid to Fahrner Asphalt Sealers, LLC at a cost of \$81,876.08. Motion carried. 5 yeas.

Resolution # 2024-37 "Increasing Garage Sale Permit Fee" was presented to Council. It was moved by Capling, seconded by Woodward to approve Resolution # 2024-37 as presented. The Resolution reads as follows: WHEREAS, Police Chief Bucholtz requested that the fee for a garage sale permit be increased from \$5.00 to \$10.00; and

Resolution # 2024-38 "Approving Judge James H. Lincoln Memorial Park Three Year Concession Stand Agreement" was presented to Council. The Resolution reads as follows: WHEREAS, the City of Harbor Beach requested bids to operate the concession stand at Judge James H. Lincoln Memorial Park; and

WHEREAS, City Manager Wruble placed an ad in the local newspaper and received two bids; and

WHEREAS, City Manager Wruble and the Administration Committee are recommending to Council that they approve a three-year agreement with Rick's Weiner Dogs in the amount of \$1,200.00 per year; see attached agreement.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Harbor Beach approves the agreement with Rick's Weiner Dogs in the amount of \$1,200.00 per year for three years to operate the concession stand at Judge James H. Lincoln Memorial Park. Motion carried. 5 yeas.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Harbor Beach approves the purchase of the 2024 Scag Cheetah II from All Season Service and Sales at a cost of \$12,900.00; Motion carried. 5 yeas.

It was moved by Woodward, seconded by Capling to approve Public Hearing for vacating a public alley on May 20, 2024. Motion carried. 5 yeas.
